Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depends on the product or service you have with us. This information can include:  • Social Security number and income  • Account balances and assets  • Transaction history
How?	All financial companies need to share customers' personal information to perform their services and run their everyday business.
